We proceeded around the loop and as we were stopped at the stop sign to continue down the hill and out of the complex the window was broken out of our car. We immediately left the premises and called Sgt. Wilke to the scene. Once out of the complex we found a rock in the passenger side floor board of our car. We did not see any suspects that threw the rock, however when we returned to see if we could located the subjects who threw the bottles everyone was gone inside. ID photographed the vehicle.
