Incident / Investigation - Case #: 08-020330

I confirmed the warrants with the magistrate and placed the suspect under arrest, putting him in back of my patrol car.

During a search of the vehicle incident to arrest I found 1 rock of crack cocaine inside a clear plastic bag located in the eye glass holder in the overhead console. Since Mr. Patton was the only person in the vehicle and the drugs were in his lunge area I determined it was his due to constructed possession.

The vehicle was towed by Rice's towing and the suspect was arrested for the Possession of Schedule II and 5 open warrants.
